1. LICENSE GRANT

You may not assign, transfer, rent, or sublicense the Software (any violation of the foregoing will result in automatic termination of the license without any right of refund). You can use the Software on any computers or Virtual Machine owned by your organization.

For Software provided to you as a subscription, you may use the Software until the completion of the subscription period.

If you purchase an upgrade or if you downgrade or otherwise change the status of a license, it is considered a change to your existing license rather than a new license, and you relinquish all rights to the version of the product that was upgraded or changed.

2. CONSENT TO USE OF DATA

You agree that LOADER and its subsidiaries may collect and use technical and related information, including but not limited to technical information about your computer, system and application software, and peripherals, that is gathered periodically to facilitate the provision of software updates, product support and other services to you (if any), and to verify compliance with the terms of this License. Data collected only

concerns the usage of the software and specifically do not include any file or partial content of the information processed by the software. Full technical details about the data collected is available upon request.

3. CHANGES

LOADER may change, discontinue, or deprecate any part of the Software (including the Software as a whole) or change or remove features or functionality of the Software from time to time. Term and Termination.
